# RESOLUTION AUTHORIZING RATE CHANGES FOR SEWER RATES FOR THE TOWNSHIP OF WEYMOUTH

WHEREAS, the Weymouth Township Municipal Utilities Authority (hereinafter "WTMUA") is tasked with the setting of rates for sewer users in the municipality of Weymouth Township in accordance with N.J.S.A. 40:14B-23; and

WHEREAS, public notice of a Rate Hearing was published in the Press of Atlantic City and the Atlantic City Record. Notice of said Rate Hearing was posted in the Weymouth Township Municipal Building and Rate Hearings were conducted on February 21, 2017 and March 21, 2017; and

WHEREAS, the WTMUA determined that adjustment of current said sewer rates are necessary to cover the costs of the WTMUA and balance the budget for the 2017 year; and

**WHEREAS**, it is the desire of the WTMUA that said sewer rates be changed to \$640.00 yearly per customer for sewer, an increase of \$4.50 per quarter per unit beginning on the second quarter of 2017.

**NOW, THEREFORE, BE IT RESOLVED**, on this 21st day of March in 2017, by the Weymouth Township Municipal Utilities Authority, Weymouth Township, New Jersey, that:

1. As of April 1, 2017, the WTMUA sets the base rate for sewer usage at \$640.00 per year per customer; and

2. WTMUA hereby authorizes Hamilton Township Municipal Utilities Authority to institute these rate changes as soon as possible.
